SAFDA Celebrates 5 years of existence

The South African Farmers Development Association (SAFDA), the hope and voice of thousands of small-scale farmers, recently commemorated its 5th anniversary.

SAFDA's AGM on 25 November 2020 was divided into two sessions, the first part being the formal part that deals with the organisation's governance matters

SAFDA was formed in 2015 through a watershed moment which was brought about by a group of growers that had had enough of the inequalities within the sugar industry.

– this session was only attended by SAFDA's delegates that were chosen from all regions that SAFDA operates in. The second part was an open session where the organisation held its 5th-anniversary celebration with invited guests.

SAFDA's anniversary did not only focus on the number of years since its establishment in 2015 but it focused beyond the number, the AGM/anniversary zoomed in on the organisation's milestones... the Industry interventions that SAFDA fought so hard for, the fertilizer assistance that growers received from the Department of Rural Development and Land reform which assisted growers to produce an increase in their output (tons of sugarcane), to name a few.

SAFDA has become a household name for many sugarcane growers' families and in the agricultural sector, hence it was befitting that it celebrates its milestone in the manner that it did. Among guests that graced the momentous occasion was the MEC for Finance, Economic Development and Tourism in Mpumalanga, Honourable Pat Ngomane, Inkosi Ngomane from Nkomazi, Ms. Joanmariae Fubbs, SASA Vice Chairperson, and many other key industry role players who are our stakeholders including National Assembly MPs. Speaking at the gathering, MEC Ngomane commended SAFDA for the work that it has done for farmers in the sugarcane space and reiterated that an organisation like SAFDA was a much-needed relief that growers had been

longing for. "SAFDA has done what government has been failing to do for growers, particularly the small-scale ones. SAFDA came at a right time when the government is working so hard to make sure that the economy is back to people through Agriculture. "umnotfo usemhlabatsini" which is loosely translated as 'the economy is in agriculture', said Ngomane. Ngomane was standing in for the MEC for Agriculture, Honourable Vusi Shongwe, who had other prior government commitments.

SAFDA's Executive Chairman Dr Siyabonga Madlala, who could not contain his happiness and joy in seeing the organisation reaching this milestone, said it was a miracle and grace that SAFDA had reached five years since it was formed. "I often do not believe it when I look at the work that has been done by SAFDA in a short space of time since it was established. There are organisations that have been existence for more than 100 years but have only achieved so little when you compare to what SAFDA has done." He added: "What surprises me the most is that in most cases organisations do not even last two years, there will be squabbles, divisions, breakaways which often lead to the demise of these organisations, but we have overcome all these obstacles by grace." Although SAFDA has had its fair share of problems, this did not stop the fast-moving ship from fulfilling its purpose and mandate for its people, he concluded.



SAFDA implements the Mkhuze rail siding project for Makhathini farmers

Recently, the South African Farmers Development Association (SAFDA) handed over the much-needed spiller to Makhathini sugarcane farmers at an event held at the Port of Durban.

The spiller is a result of a plea that was made by the farmers to the Department of Agriculture, Land Reform and Rural Development (DALRRD) after their local mill informed them it would no longer be able to continue with the road transport subsidy for the Makhathini small-scale farmers. The DALRRD agreed to fund the operationalization of Mkhuze siding to a tune of R30 Million to support the small-scale farmers for the transport of their cane by rail to the Felixton mill, hence also increasing cane throughput to the sugar mill. This Mkhuze rail siding project will assist about 1900 Makhathini small-scale farmers who have been struggling for some time now. Speaking at the launch, SAFDA Executive Chairman Dr Siyabonga Madlala, said this was the beginning of many great things to come for Makhathini farmers. "This spiller will bring the much-needed relief to our small-scale growers, the reduction of costs will definitely expand their operations with the savings that they will be making through the operation of this rail," added Madlala.

Jobs will be created during construction and operations of this project. Construction jobs will also be created as the project moves forward with civil works over the next 2 to 3 months. Once construction is completed, operational jobs will be created for spiller operators, road weigh bridge clerks, spiller and weigh bridge

cleaners, wagon cleaners, mobile cane loading machine operators, rail tractor operators, security, and site supervisor. A minimal of 20 operational jobs is expected to be created at the Mkhuze rail offloading facility. Local businesses will benefit from civil, structural, mechanical, and electrical procurement such as in building materials and steel work, machinery, and equipment (tractors, generator, excavators, bell

loader, weigh bridge and office building materials) and lighting and electrical installation.

Bosch Holdings has been appointed as the consulting design engineers to the project, and the design has been completed. Timing of this project is critical to the livelihoods of the Makhathini small-scale farmers, as the farmers need to shift from road to rail at the start of the 2021 sugar season, so that their cane is not left stranded in Makhathini. This project would support a reduction in the volume of trucks on the road especially on the N2 north of Richards Bay to the Jozini off-ramp which is single lane each direction.

Mazwi Simelane, Chairman of Makhathini Farmers, said they had really struggled in the past years, with the expensive costs of transporting sugarcane to the mills. "The excessive costs that we used to incur for transporting sugarcane to the mills is the reason today we see a decline in farmers who grow sugarcane in Makhathini area, the costs are beyond what we can afford, having this rail will make huge savings for most of us," said Simelane.



The Makhathini sugarcane farmers are currently transporting their cane by road to the Felixton sugar mill and are currently paying R170 per ton with the rest of the costs covered by the mill subsidy. With the new transloading station, their total costs will reduce to R112 per ton. At approximately 117 000 tons of sugarcane from Makhathini currently per year, this equates to a total saving of R6.8 million per year for these small-scale farmers. Over time as the cane production potential increases for the Makhathini farmers delivering 350 000 tons using the new transloading facility would save the Makhathini small-scale farmers R16 million per year.

SAFDA subsidiary to conduct monitoring and evaluation over food security programme for government

The Department of Agriculture and Rural Development (DARD) in KwaZulu-Natal has appointed SAFDA Farm Management Services (Pty) Ltd as a commodity organisation for 36 months to conduct the monitoring and evaluation of the multi-season planting programme to plant 20 938 hectares throughout the province for the following financial years: 2020/21, 2021/22 and 2022/23.

According to the Agricultural Policy Action Plan (2014-2019), food security remains a challenge for the country, especially at local household levels. The most vulnerable sector of our society is our rural communities who are the most impoverished citizens, yet there is so much land at their disposal, with a lack of resources to make use of the arable land surrounding them. In response to the plight of the rural communities, the department has introduced the Multi-Season Planting Programme to focus mainly on summer crops that are stable food such as maize, beans, and vegetables, any surplus of these produce should be linked to Radical Agrarian

Socio-Economic Transformation (RASET) programme.

The department had to intervene with an aggressive and a holistic programme to address food security in the province, especially for the marginalised farmers, for food security and to participate in the mainstream agricultural economy. The provincial government launched this programme led by Premier Sihle Zikalala. The event took place in October 2020 in the uMzimkhulu Municipality area, which falls under Harry Gwala District. The aim of the launch was to create awareness for the farmers involved in the programme and for local markets to recognise this programme. The scope of the project is to review the planting season programme documents including data collection templates, portfolio of evidence documents set indicators to measure performance. Focus on strengthening the M&E System, building capacity of extension officers, and producing credible data and quality M&E systems.

2020/2021 SEASON – Road to recovery for the Sugar Industry

The sustainability of the sugar industry had been under threat in previous years due to the ineffective tariff protection, which led to erosion of value, as large quantities of imported sugar flooded the market and exposed local sugar production to the 'dumped' world market at prices below the cost of production. More recently the introduction of the Health Promotion Levy (HPL) has had a devastating impact on sugar demand, particularly from industrial users in the beverage sector. The HPL is estimated to have shrunk local market demand for sugar by about 20%, which contributed to a marked reduction in industry-related jobs, with many small-scale farmers exiting the industry due to the significant reduction in revenue. Industry revenue in the 2019/2020 season declined by R2.2 billion following implementation of the HPL.

Government response to the crisis facing the sugar industry was the formulation of the Sugar Industry Value Chain Masterplan 2030 (Masterplan), which seeks to ensure stability, growth, and long-term sustainability for the sugar industry. Short-term objectives of the Masterplan aim to restore local market demand for sugar in the first year of implementation by at least 150 000 tons and by 300 000 tons by year

three. Industrial users and retailers have committed to a 'buy local campaign', which requires users to source at least 80% of their requirements from local sugar production. This commitment to purchase South African sugar increases to 95% by year three. In return sugar industry stakeholders have committed to restraining notional and producer price increases to within consumer price inflation for a period of three years, thereby ensuring that future price increases are competitive and sustainable for customers. Government has also committed to promote the use of local sugar by all government departments and state-owned entities. It is extremely encouraging for small-scale farmers to note that one of the strategic objectives of the Masterplan is to ensure that "Small-scale farmers are foundational to the long-term future of


the sugarcane-based value chain"

The Masterplan was approved in principle by all major stakeholders in April 2020 but due to the delay caused by Covid 19 pandemic, it was officially launched in November 2020. Although the official launch was in November 2020, all stakeholders appear to have honoured their commitments from the outset, when the Masterplan was adopted in April 2020. This has been evidenced by a substantial increase of the Local Market Demand Estimate (LMDE) which has grown by 211 000 tons; from a level of 1 249 476 tons at the start of the 2020/2021 season to the current LMDE of 1 460 308 tons. It is apparent that the Masterplan has exceeded the achievement of its year one objective (150 000 tons) and this has boosted -industry local market proceeds by R2.2 billion and thereby impacted very favourably on the 2020/2021 RV price.

It was initially expected that Covid 19 would curb sugar demand and this assumption was used in determining the conservative LMDE levels at the start of the 2020/2021 season. However, it turned out that the positive food demand impacts of Government interventions were grossly underestimated. Government interventions such as the additional R500 on the social grant allowance, R350 monthly stipend for the unemployed individuals and distribution of food parcels had a positive effect on food consumption and the sugar industry has benefited greatly from these interventions.

We now have few weeks left before the end of the 2020/2021 sugar season and the evidence thus far suggests that the implementation of the Masterplan has contributed significantly towards setting the sugar industry off on the road to recovery and transformation. Local market sugar demand has exceeded year 1 aspirations of the Masterplan. Overperformance of the estimate by local market sales has prevailed for the entire season and we anticipate a similar upward trend for the remainder of the season. The increase in local market sugar demand has reduced exposure to the loss-making world market. Compared with the previous season (2019/2020) the export sugar availability has decreased by 392 889 tons (574 690 tons vs 967 579 tons).

This has contributed to higher average realised prices for the industry and improved grower revenue.



The positive impact on the 2020/2021 RV price can be seen in the graph below.

The above graph illustrates the monthly RV price trend from the beginning of the season up to January 2021. The latest provisional RV price paid to the

sugarcane growers at the end of January 2021 was declared at R5 008,99 per ton of RV. This represents an increase of R788,41 per ton (18,7%) compared

with the final RV price for the previous season (2019/2020). Considering the impending inflationary notional price increase effective from 3 March 2021, it is estimated that the final 2020/2021 RV price could improve to above the R5050 mark. The adoption of the Masterplan has been very positive for the South African sugar industry based on the evident substantial growth in local market demand seen thus far. This is a very positive development for the sugar industry particularly small-scale growers because it will promote greater transformation, development, and sustainability in the industry. We look forward to the next two seasons of the Masterplan which is aimed at further restoration of local market demand and industry value. There are still challenges to be addressed namely, the increasing volume of sugar imports from Eswatini, which contributes significantly to the erosion of value.

SAFDA led bulk water project underway in Mpumalanga

The Mpumalanga team, led by the Grower Support Division's Head Sifiso Mnguni, has embarked on a journey to look for other ways to further reduce production costs for small-scale growers in the Nkomazi irrigated region.

An analysis of all costs involved in producing one hectare of sugarcane was conducted, and it was identified that electricity, haulage, and irrigation represented close to 75% of overall cost of production. The team tasked with the implementation of this project then realized that irrigation

is done on a service provider basis, which did not have any competition in this case. In the entire sugarcane region, two mill areas of Mpumalanga, it was discovered that there was a monopolistic practice with regards to the provision of service and this had an adverse impact on some growers.

As a matter of background, SAFDA Farm Management Services (Pty) Ltd, was given an opportunity by Walda Project to manage their irrigation infrastructure from June 2020, hence the birth of SAFDA Bulk Water Supply. This was in response to the strategic pillar of SAFDA to provide transformation for the growers in the industry. The response was also to provide a cost-effective model, that will contribute towards reducing the costs of production for all small-scale growers in the region, thus participating in the value chain backed by the fifth pillar of the organization.

Presentations to share the vision of a cost recovery model of a SAFDA



Bulk Water Supply (BWS) irrigation scheme were done on two small-scale projects (Sibange and Walda Farmers' Associations) that had ended their contracts with the only service provider in the region. Both projects were interested in the idea, and Sibange did not hesitate to sign a

five-year contract with SAFDA BWS, which is scheduled to commence in the 2021 season. There were challenges to get a contractor that would start immediately in July on the huge small-scale grower project with approximately 800 hectares of area under cane in Walda project.

No matter how exciting and well-structured the SAFDA BWS model had promised the growers at the project, the differences in affiliation to an industry grower association among the growers in the project got in the way. Those that were not affiliated, politicised the introduction of the SAFDA BWS as a model meant for SAFDA-affiliated growers. The matter was eventually settled through a democratic process and SAFDA BWS was voted in to render the service starting from July 2020.

Mr Nhlanhla Ngomane was seconded by the Mpumalanga team to manage the operations of the project, with technicians from Minatlou Trading (Pty) Ltd appointed as the technicians on the ground for all related breakdowns from the pump houses, to the mainline, to the sub-

mainline and up to infield pipes.

To date, the scheme has had its challenges, and opportunities. The challenges ranged from political and mill area interferences, financial constraints, management structure, and natural disasters. However, the newly appointed Operations manager of the Mpumalanga team, Florence Mavimbela, has brought hope in assisting the team with the challenges faced. The executive support from SAFDA Head office also ensured the survival of the project. The SAFDA Bulk Water Supply irrigation scheme will indeed continue to exist in the region, with future opportunities because more projects have shown interest to join in the 2021 season going forward. With a hope to have a cost saving model that provides the required quality of service.

Importance Of Socio-economic Survey

Sugarcane is one of the most important unique industrial commodities because of its immense contribution to Gross Domestic Product, it is also a major employer for most households. Sugarcane is one of the commodities that is used daily almost by everyone around the world. It is mainly produced in two provinces in this country namely, KwaZulu Natal and Mpumalanga Province. South African Farmers Development Association is currently working on research that will be based on a socio-economic survey of our small-scale farmers and it will be conducted on these two provinces using structured questionnaires. All ethical issues and covid-19 regulations

will be adhered to when conducting this social research. The socio-economic survey aims to determine the list of key socioeconomic areas of concern in the site context and for ongoing database purposes. We will be using local language which is IsiZulu in the interpretation of questions. The questions will be asked in IsiZulu as the preferred language, as some respondents are illiterate and unable to understand the English language.

As more data will be collected in respect of the goals of the research program assessing the socio-economic demographic profile of small-scale farmer

irrigated and non-irrigated agriculture, it becomes clearer that the focus should be more on why the households are resisting the incentives on offer. It continues to be a source of deep concern that, since 1994 the promises of land reform to integrate the smallholder black farmers into the agricultural economy of the country, little progress has been made. It is impossible to deny the fact that a lot of political will has been deployed into the question of the transformation of the agricultural sector. Thus far, the response has not been encouraging, and in many situations downright disappointing.

Therefore, the socio-economic survey is vital mostly for statistical data on the household budget and other geographic information characteristics of the area and their living conditions. In addition, the data is mostly generated to understand the economic sphere of smallholder farmers in both provinces. However, the area of policy planning and implementation is generally in the sphere of politicians as the ultimate decision-makers due to the system of our government. But in doing such responsibilities, politicians need to use advisory such as economic advisory, finances, etc which is not an area of competence to them for most. At the same time, the socio-economic survey will also examine the situation of the smallholder farmers concerning crop diversification not only limited to sugarcane and whether there are existing gaps that called for policy shifts to improve the workings of the system.

SAFDA rewards growers for farming excellence

For the first time since its formation and in an exciting development, the South African Farmers Development Association (SAFDA) will this year (2021) host its inaugural Annual Farmers Awards Ceremony.

The awards ceremony, which was initially planned to be held in Durban earlier in the year, will now be held on a date yet to be announced. Awards are based on the work performed by participating farmers during the 2020-2021 season.

The objective of the initiative is:

- To reward good farming, thereby encouraging farmers to keep up the good work
- To use the event to appreciate partners and stakeholders for their assistance and contribution to SAFDA's work of supporting the development of farmers

While the initiative will be sustained as an annual event, which will eventually include all commodities, for the 2020-21 farming season, the focus is on the sugar commodity, black small-scale and land reform farmers across the two

sugar producing provinces of KwaZulu-Natal and Mpumalanga. Candidates' nominations process which started in September 2020 and culminated with the profiling of nominees conducted in December last year. The event is set to honour a range of stakeholders who are currently involved in sugarcane farming and in support of the business of farmers. Awards will be given in the following categories:

Grower Leadership

Award in this category will be given to one farmer considered to have best performed in demonstrating leadership in the farmers' association, SAFDA.

Supporting employee

Award in this category will be given to one employee voted by majority of farmers to be the best supporting SAFDA employee across KZN and Mpumalanga.

Project

This best project award will be given to a team of employees who led the implementation of a project voted by majority of farmers to have had the most effect in improving farmers' business.



Contractor

The farming contractor award will be given to one contractor considered to have been the most performing and efficient service provider to farmers in various aspects of cane contracting.

Contributing Commercial Farmer

This one award will be given to one established commercial farmer considered to have demonstrated selfless effort to assist small-scale farmers in dealing with one or more of their challenges.

Contributing Partners

This one award will be given to one or more partners and grant makers or donors who have supported the work of farmers through partnering with the association, SAFDA.

Mill Area Committee (MAC)

Mill area committees are sugar mills-based farmer committees established to handle and process farmer issues from ground to higher levels of the industry.

This award is given to a considered to be the best in performance for the season.

Restitution Award

Restitution award is given to the best performing Communal Property Association (CPA) or Community Trusts in respect of best handling and managing pre and post settlement aspects of their community's restitution claim.

Chairman's Award

The Chairman of SAFDA awards this award to an individual or organisation chosen by the chairman of SAFDA as a special contributor, among others. Farmers will be awarded according to

scale of farming, i.e. small-scale, land reform (medium) and large scale. Special categories of women and youth have been created to acknowledge and encourage women and youth

participation in agriculture. In this category, awards will include Best new farmer; Best small-scale farmer; Best Land Reform farmer; Best Large-scale farmer; Best female farmer; Best young farmer; Best supporting commercial farmer; and the SAFDA Farmer of the Year (overall).

As part of candidates' eligibility criteria, participants must be part of or stakeholders or supporters in the sugar production business. Farmers must be participating in at least one or more of SAFDA coordinated farming activities or projects.

I-SAFDA iqala iprojekthi yomgwaqo waseMkhuze obheke kujantschi ngokumela abalimi abancane abantu 1900 bakwa Makhathini. Lokhu kulandela isicelo sabalimi abasibhekise kwi-Department of Agriculture, Land Reform and Rural Development (DALRRD) ngemuva kokuthi I-Tongaat Hulett Sugar (THS) iveze ukuthi angeke isakwazi ukuqhubeka nesibonelelo sokuthutha ngomgwaqo ebesenikezwa abalimi abancane bakwa Makhathini. I-DALRRD ivumele ukuxhasa ngezimali zokwenza umsebenzi we-Mkhuze siding ukuze kusizwe abalimi abancane bakwazi ukuthumela umoba wabo ngojantshi emshinini wase-Felixton, okuzokhulisa nomkhiqizo womoba ongena kulomshini ogaya umoba. I-Botch Holdings ibekwe njengenkampani yonjiniyela abazokongamela lephrojekthi, futhi sekuphothuliwe ukubhalwa ngezinholelo zaledphrojekthi. I-SAFDA isiqedile ukuthenga i-Spiller esivela eBrazil. Ukuthengwa kwezinsizakusebenza zobunjiniyela nakho sekuse sigabenzi sokuphothulwa, kwisayithi yaseMkhuze.

Isikhathi okuhlongozwe ngaso lephrojekthi simqoka kwimizamo yokuziphilisa kwabalimi abancane, njengoba abalimi kufanele bashintshe ekusebenziseni umgwaqo basebenzise ujantschi uma kuqala i-season kamoba ka 2021, ukuze umoba wabo ungasali dengwane kwa Makhathini. Okunye, umnikazi we-siding yakwa-Transnet Freight Rail (TFR) baveze

ukuzinikela kwabo kulephrojekthi futhi usebenziana nethimba elenza nabalimi ukuze kuhanjiswe umoba kwi-siding yaseMkhuze iyiswa emshinini.

Umthelela

Lephrojekthi izoba nomthelela omkhulu ekuziphiliseni kwabantu abahlala ezindaweni zasemakhaya ezifundeni ezihwempu zakwaZulu-Natali. Abalimi bomoba bakwa Makhathini abadlule ku 1900 njengamanje bathumela umoba

Abalimi bomoba bakwa Makhathini abadlule ku 1900 njengamanje bathumela umoba ngomgwaqo emshinini eFelixton futhi bakhokha uR170 ithani ngalinye mese kuthi ezinye izindleko zinakekelwe isibonelelo se-THS. Ngesiteshi esisha sokulayisha, izindleko sezisonke zizonciphha ngo R112 ngethani ngalinye. Kumathani abalelwu ku 117 000 omoba avela kwa Makhathini ngonyaka, lokhu kulinganiselwa kwinani eliku R6.8 million ngonyaka elizokongiwa ilabalimi abancane.

Ngokuhamba kwesikhathi uma umkhqizo kamoba Ukhuphula ufika kumathani angu 350 000 akhishwayo besebenzisa indawo yokulayisha entsha, abalimi abancane bakwa Makhathini bazokwazi ukonga uR16 million ngonyaka. Ngaphezulu komthelela omuhle ngokwezimali nezingqalasizinda okulethwa ilephrojekthi, ukuyeka ukusebenzisa umgwaqo kuiwe kujantshi kuzonciphisa ukungcoliswa komoya ngokuhambisana nemithetho kahulumeni nemigomo ye-Kyoto. Okunye ukuthi lephrojekthi izoxhasa imizamo yokunciphisa umthamo wamaloli ahamba ku N2 kusukela eRichards Bay kuya kwi-off ramp yase-Jozini, enomzila onohlangothi olulodwa emigwaqeni yomibili.

Imisebenzi namathuba kumabhzinisi endawo

Amathuba emisebenzi ayavela njengoba kwakhiwa futhi kusetshenzwa kulephrojekthi. Ukulingiselela isayithi abe-TFR sebeqashe amathimba ahlukene azokhculula izihlahla nokhula ukulungiselela ukwakhiwa kwalesayithi. Kuzokwakhiwa imisebenzi yokwakha uma sekqhutshewa nokwakhiwa ezinyangeni ezimbili noma ezintathu ezizayo. Uma sekqedive ukwakhiwa, kuzobe nemisebenzi yama-operator e-spiller,



omabhalane bakuma-weighbridge, abahlanza bama-weighbridge, abahlanza bezinqola, ama-operator azoshayela imishini yokuthutha umoba nabazolayisha, abashayeli bogandaganda, onogada kanye nezinduna zesayithi. Okungenani imisebenzi engu-20 okubhekwe ukuthi yakheke kulesakhiwo sojantshi waseMkhuze.

Amabhzinisi endawo nawo azohlomula ngokuthengwa kwezinsiza zokwakha, imishini nezinto zikagesi okubalwa kukho impahla yokwakha, izinsimbi, imishini (ogandaganda, ama-generator, ama-excavators, ama-bell loader, nezimpahla ze-weigh bridge nezasemahhovisi) kanye nokufakwa kukagesi.

2020/2021 SEASON – Idlela ebheke ekululameni kwemboni KaShukela

Inqubekela phambili yemboni kashukela ibilokhu isengcupheni eminyakeni edlule ngenxa yokungavikeleki kahle ngama-tariff, okudale ukuthi kwehle inani lemikhqizo, njengoba ushukela omuningi ezimakethe ubuvela emazweni angaphandle, okwenze ukuthi umkhiqizo kashukela wakuleli 'ulahlwe' ezimakethe zomhlaba ngamanani aphansi kakhulu adlula izindleko zokuwukhqiqa. Kamuva nje, ukwethulwa kwe-Health Promotion Levy (HPL) kushiye imboni kashukela ishayekile kakhulu, ikakhulukazi kulabo abakwimkhakha ewusebenzisa ukukhqiqa iziphuzo. I-HPL kubalwa ukuthi ishwabanise ukuthengwa kwashukela ngo-20% okube nomthelela ekuncipheni kwemisebenzi kulomkhakha, nabalmi abancane baphuma kulomkhakha ngenxa yokungangenisi imali. Imali engeniswe ilemboni ngo 2021/2020 inciphe ngo 2.2 billion ngemuva kokwethulwa kwe-HPL.

Ukuphendula kukahulumeni kwinklekelele ebhekene nemboni kashukela kubekwala kwe-Sugar Industry value Chain Masterplan 2030 (Masterplan), ebheke ukuqinisekisa ukuthi lemboni iyazinza, iyakhula futhi kunenqubekela phambili embonini kashukela. Izinhlelo zesikhathi esifushane ze-Masterplan ukuthi kubuyiswa izinga lokuthengwa kwashukela kulelizwe onyakeni wokuqala waloluhelo okungenani kubekwala ngamathani angu 150 000, mese kuba ngamathani angu 300 000 eminyakeni emithathu ezayo. Izimboni

ezisebenzisa ushukela sezizinikele ekutheni "umkhiqizo wasekhaya"; okudinga laba abasebenzisa umoba bathenge okungenani u-80% womoba okhiqizwa kulelizwe. Lokhu kuzinikela kwalezimboni ukuthi zizothenga umoba okhiqizwa eNingizimu Afrika kuzonyuka ngo 95% ngonyaka wesithathu.

Ababambiqhaza embonini kashukela sebezinikele ukuthi bahoxise ukwenyusa kwamanani ukuze ahambisane nezinga lokunyuka kwemali engena kubathengi kuleminyaka emithathu ezayo, lokhu okuzoqinisekisa ukuthi ukuncintisana kwamanani kuhle futhi nabathengi bayakwamukela. Uhulumeni usezibophezele ukukhangisa nokutusa ukusetshenisa koshukela wakuleli kuyo yonke iminyango kahulumeni nasezinkampanini ezizimele. Kuyakhuthaza kakhulu kubalimi abancane ukubona ukuthi enye yezinhloso ezikhona kwi-Masterplan ukuqinisekisa ukuthi "Abalimi abancane bayisisekelo futhi babalulekile esikhathini


esizayo emnothweni womoba"

I-Masterplan yagunyazwa ngokuvumelana kwabo bonke ababambiqhaza ngo April 2020 kodwa ngenxa kokubambezeleka okudalwe ubhubhane lwe-Covid 19, yethulwe ngokusemthethweni ngo November 2020. Noma ukwethulwa kwayo kube ngo November 2020, kodwa bonke ababambiqhaza bakhombise ukuzinikela kusukela kuqala isivumelwano ngo April 2020. Lokhu kufakazelwa ukukhula kakhulu kwe-Local Market Demand Estimate (LMDE) okuchaza ukuthi umkhiqizo kamoba ubusuthengwa kakhulu kuleli, okukhule ngamathani angu 211 000, njengoba abeku 1 249 476 amathani ekuqaleni kuka 2020/2021 kodwa manje i-LMDE isiku 1 460 308 wamathani. Kuyabonakala ukuthi i-Masterplan ishaye yadlula kulokhu obekulindelekile kuyo ngonyaka wayo wokuqala (obekungamathani angu 150 000) futhi ikwazile ukuthuthukisa izimakethe zalapha ekhaya kulemboni ngemali engu R2.2 billion okube nomthelela omuhle kwinani le-RV lonyaka ka 2020/2021.

Bekulindelekile ekuqaleni ukuthi i-Covid 19 izokwehlisa izinga lokuthengwa kwashukela, futhi lomcabango usoetsheniselwe ukubeka i-LMDE ephansi ekuqaleni konyaka ka 2020/2021. Kodwa ukuthengwakokudla kakhulu ngenxa yemizamo kahulumeni ukusiza abantu bekungabhekisisiwe kakhulu. Ukungelela kuka hulumeni okufana nokunyusa imali yesibonelelo ngo R500, no-R350 onikezwe abantu abangasebenzi njalo ngenyanga kanye ngokunikezela ngamaphasela okudla kubekwala nomthelela omuhle ekuthengweni kokudla nasemonini kashukela.

Kusele amasonto ambalwa ngaphambi kokuthi kuphele i-season ka 2020/2021 kashukela kanti ubufakazi obutholakele buveza ukuthi ukusungulwa kwe-Masterplan kubekwala nomthelela omuhle kakhulu ekutakuleni nasekushintsheni imboni kashukela. Ukuthengwa kwashukela ezimakethe zalapha ekhaya kudlule izifiso ebezilindelekile ngonyaka wokuqala we-Masterplan. Ukwenza kahle kwezimakethe zalapha ekhaya sekusindise i-season yonke futhi sibheke ukuthi lokhu kuqhubeku kuze kuphele i-season yonke. Ukuthengwa kakhulu kwashukela ezimakethe zalapha ekhaya sekunciphise amathuba okuba ingxenye yezimakethe zomhlaba ezihambi kahle. Uma kughathaniswa ne-season edlule ka 2019/2020 ukudayiswa kwashukela emazweni angaphandle kwehle ngamathani angu 392 889 (amathani angu 574 690 eqhathaniswa nangu 967 579).

Lokhu kubekwala nomthelela ekunyukeni kwamanani embonini futhi kwakhulisa nemali eyenziwa abalimi.

LeSpiller singumphumela wesicelo sebelimi labasenta ku Department of Agriculture, Land Reform and Rural Development (DALRRD) emuva kwekutsi umshini wendzawo ubatjele angeka usachubeka ngekubabonelala ngemali yetekutfuta kwebelimi base Makhathini labancane. 2020/2021 SEASON – Idlela leya ekubusiseni kwemboni yashukela

Kusimama/kucina kwe kwemboni yakashukela bekusengcopheni kuleminyaka leyengcile ngenga yekungavikele kwekutsengisa kwashukela, loku kuholele kutsi intsengu yashukela yehle, ngekungena kwashukela lominingi lobuya emaveni angaphandle kwabangela kutsi shukela lokhicitwa kulelive 'kunganakeki' emakethe mhlaba wonke nekutsengwa kwavo kubengaphansi kwetindleko tekulima. Kufakwa kwe Health Promotion Levy (HPL) kube nemtselela kutfusako ezingeni lekudzingeka kwashukela, ikakhulukati kubasebenti kumbe batsengi bashukela. Kulinganiswa kutsi le-HPL inciphise linani lekufunwa kwashukela nga 20%, lokube nemtselela wekwehla kwemisebe leyamaniswe nemboni, nekutsi belimi labancane batfolakale sebaphuma kulemboni ngenga yekwehla kakhulu kwenzuzzo. Emnyakeni wa 2019/2020, inzuzzo yehle nga R2.2 billion kulandzela kucala kweHPL.

Hulumende ubese ucala i-Sugar Industry Value Chain Masterplan 2030 (Masterplan) kumelana nalengcinamba lebukene naalemboni yashukela, lefunu kubukana nekucinisekisa kwekusimamisa, kakhulu kanye nekucina kwemboni yashukela. Kulesikhatsi lesifisha lesitako le-Masterplan ibuke kubuyiselwa kufunwa kwashukela welive emnyakeni wekucala icaliwe ngemathani lalinganiselwa ku 150 000 bese kuba ngulangu 300 000 ngemuka wesitstfu. Basebentisi bashukela nebatsengisi batibophele

ekutsengeni shukela lokhicitwa kulelive, loku kudzinga kutsi basebenti bafune lokungenani shukela longe ma 80% lokhicitwa kulelive. Lokutibophelela ekutsengeni shukela lokhicitwe eNingizimu Afrika kutophakama nga 95% ngemnyaka wesitsatsu. Ngalokunjalo labatsintsekako embonini yashukela batibophele nekumelana nekuphakamisa kwentsengu yemkhiciti ibe phakatsi kwetsengu yemtsengi esikhatsimi seminyaka lemitsatfu, ngako ke kutocinisekisa kutsi intsengu yakusasa ingulekahle futsi mutsengi naye itomusimamisa. Hulumende naye utibophelele kuphakasa kusetjentiswa kwashukela wakuleli kuwo onke ematiko akhe kanye natotonke tindzawo letingaphansi kwahulumende. Kuyabagcugcutela kakhulu balimi labancane kubona kutsi yinye yaletintfo letiku Masterplan kucinisekisa kutsi "belimi labancane banesisekelo tikwelikusasa ekukhiciteni kwashukela.


Le-Masterplan yavunyela yaphasiswa ngemgomo ngiwo onke emalunga laphakemengenyanga Mabasa kodvwa ngenca yekubambeleka lokubangelwa yi-Covid 19, yacalwa ngenyanga yeLweti 2020. Nanoma kunjalo kutsi yasungulwa ngenyanga yeLweti, onke emalunga abonakala kuhlonipha letibopha khona lapho layamukelwa khona leMasterplan ngenyanga yaMabasa 2020. Loku kufakazelwa ngulokukhula kwe Local Market Demand Estimate (LMDE) lokukhule ngemathani langu 211 000; asuka kumathani langu 1 249 476 ekucaleni kwemnyaka wa 2020/2021 kuya kuLMDE yemathani langu 1 460 308. Kungumanje leMasterplan seyivele ingetulu kwaloku beyibuke kutsi itakuza ngemnyaka wekucala (lokungemathani langu 150 000) futsi kwacinisa imali yemboni nga R2.2 billion ngaloko ke kube nemtselela lomuhle tikwentsengu yeRV yanga 2020/2021.

Ekucaleni bekulindzeleke kutsi i-Covid 19 itawunciphisa kudzingeka kwashukela futsi lomcabango wasetjentiswa kweteka kwelizinga leLMDE ekucaleni kwemnyaka wa 2020/2021. Kodwa, kujike kwaba nemtselela lomuhle ekudzingeni kwekuldra ngekungenelela kwaHulumende lebekulinganiselwe phansi kakhulu. Kungenelela kwahulumende njenge kungetwa kwemali yesibonelelo lengu R500.00 na R350.00 leniketwe labo labangasebenti kanye nekuhamjiswa kwemaphasela ekudla kube nemtselela lomuhle kakhulu ekudleni kwekuldra kantsi ke nemboni yashukela izuze kakhulu kulokungenelela kwahulumende.

Kwanyalo siselelwe maviki lambalwa kutsi umnyaka wa 2020/2021 ufile ekugcineni futsi bufakazi bukhomba kutsi lokusungulwa kwale Masterplan kufake sandal lesikhulu kakhulu ekucinisekiseni sendlela yekubuyiswa kwemboni yashukela kanye nengucuko. Imakethe yashukelwa kuleli iphambili kwaletifiso temnyaka wekucala waleMasterplan. Kusebenta ngalokungetulu kwesilinganiso sekutsengiwa kwemakethe yakuleli sekuvele kwancoba umnyaka wonke futsi kukhombisa kutsi kutawuchubeka ngelizinga lelifanako lekuphakama kuletinyanga letisele kulomnyaka. Lokuhula kwekuldra shukela wakuleli kuciphise ingoti yekulahlekelwa emakethe yasemaveni.umakucatsaniswa nemnyaka wa2019/2020 shukela lochamuka ngaphandle wehle ngemathani langu 392 889 (574 690 vs 967 579 mathani).

Loku kube nemtselela lomuhle kakhulu kulizinga leliphakeme letintsengu embonini kwaphakamisa imali leyentiwa belimi.
