#### 2. Job Description

- Formulate a Construction Contract Arrangement Document that comprises a suite of documents prepared to regulate the terms of the agreement between SAFDA (South African Farmers Development Association) and the "appointed service provider". Such compiled document to be kept as generic as possible and all project specific issues to be dealt within the appropriate annexures in the interest of standardization and good practice.
- Define key parties to the contract and the role players in the contract as well as their detailed description of their respective roles.
- Interrogate SAFDA preferences advise where necessary on appointments for establishing a project brief, objectives, priorities, constraints, assumptions, and strategies correctly translated to a suitable construction contract agreement.
- Interrogate SAFDA overall approach to implementation, limitations, exclusions, measures of success and completion criteria.
- Develop terms of the contract in respect to time, cost, and quality for signature by the client and the employer.
- Formulate tender's data document that establishes the tenderer's obligations in submitting a tender and SAFDA as the employer's undertakings in administering the tender process and evaluating tender offers prior to appointment
- Formulate a project risk management plan for major risks grading such from low, medium, and high based on the adverse risk to project completion.
- To formulate a targeted enterprise strategy an approach which is pursued to make a contract participation goal an obligation and pre-requisite of the contract agreement.
